

**PARTNERSHIP AGREEMENT
BETWEEN**

Pickaway-Ross Career and Technology Center, 895 Crouse Chapel Road, Chillicothe, Ohio 45601, the applicant and stakeholder, and

Lighthouse Youth Services, Inc., 401 E. McMillan, Cincinnati, OH 45206, its program, Lighthouse Youth Center at Paint Creek, 1071 Tong Hollow Road, PO Box 586, Bainbridge, Ohio 45612 operating the Paint Creek Academy as an Ohio Department of Education chartered Private School, and its successor schools, if any, the implementing agency.

Whereas, Pickaway-Ross Career and Technology Center has provided human and material assets and access to academic and administrative resources to Lighthouse Youth Services and its program, Lighthouse Youth Center at Paint Creek, the grant applicant, to execute a Straight A Fund grant application.; and

Whereas, the applicant is in support of the proposal as submitted to the Ohio Department of Education on October 25, 2014,

The two entities now agree to the following partnership for the duration of the grant period:

1. As the grant applicant, Pickaway-Ross Career and Technology, is responsible for ensuring the grant is developed and executed according to the terms of the grant agreement with the Straight A Program Governing Board.
2. As the grant applicant, Lighthouse Youth Services, Inc. agrees to report and consult regularly with the grant applicant to ensure the grant is developed and executed according to the terms of the grant agreement with the Straight A Governing Board, including but not limited to, update phone calls and emails, meetings and on-site visits.
3. In support of the proposed program, Pickaway-Ross Career and Technology will provide administrative services to manage the grant, and additional consultation with the grant applicant, including, but not limited to:
 - Development of a contract with details on draws against the grant funds and required financial and program reports;
 - Expertise and guidance to Paint Creek Academy in implementing Ohio Department of Education curriculum, Pathways of Study, and Articulation agreements for which the CTPD holds current in Horticulture and Information Technology programming.
 - Participation in monthly project meetings;
 - Opportunities for additional consultation on program elements.
4. In support of the proposed program, Lighthouse Youth Services, Inc. will provide implementation of the activities and outcomes detailed in the grant, including but not limited to:
 - Activities detailed in Section 12 of the application, on the timeline detailed in Section 18;
 - Report immediately any deviation from the timeline or expenditures agreed upon in the grant application;
 - Timely financial and program progress reports on a schedule to be determined;
 - Documentation to back up expenses incurred for draw-downs of grant funds;
 - Access to Continuous Quality Management reports and meetings;


- Other consultation and reports that assist the Applicant to effectively measure project progress and outcomes.

Further, each member of the partnership is responsible for the following assurances:

1. Be knowledgeable about the applicant's Straight A Fund grant proposal and application, including advocacy of the Straight A Fund program.
2. Maintain familiarity with the partner's services to enhance the proposal, including specific goals and practices.
3. Demonstrate a commitment to clear roles and responsibilities of each partner as it relates to the grant proposal and application.
4. Sustain consistent communication among partners and stakeholders with a shared vision of the goals of the grant proposal. This includes participating in regularly scheduled meetings for project management and identifying areas for improvement.
5. Ensure partners have appropriate access to data for purposes of grant program improvement and evaluation in accordance with state and federal law.
6. Develop a clear project management plan to sustain the project over time.
